

## Transmission Service Reassignment Agreement

This Transmission Service Reassignment Agreement (this “Agreement”), dated \_\_\_\_\_, between \_\_\_\_\_ (or “**Reseller**”) and \_\_\_\_\_ (or “**Assignee**”), regarding the assignment of transmission service in accordance with the terms and conditions set forth herein. **Reseller** and **Assignee** hereinafter maybe individually referred to as the “Party” or collectively as the “Parties”.

WHEREAS, **Reseller** has reserved certain rights to transmission service on the transmission system of \_\_\_\_\_ (“**Transmission Provider**”) pursuant to the following OASIS numbers \_\_\_\_\_, and now desires to assign such rights; and

WHEREAS, **Assignee** has entered into a service agreement for the resale, reassignment or transfer of Firm Point-To-Point Transmission Service (“Service Agreement”), and desires to accept assignment of such rights.

NOW THEREFORE, in consideration of the foregoing and the mutual promises set forth herein, the Parties agree as follows:

### 1. Assignment.

Unless otherwise agreed to by the Parties, **Reseller** assigns, transfers and conveys **Reseller’s** rights to the transmission service, as indicated herein, to **Assignee** effective as of the date of the Service Agreement.

**Reseller** and **Assignee** agree to cooperate to complete the assignment and substitute **Assignee** as the transmission customer in accordance with the procedures required by **Transmission Provider**. **Assignee** accepts the assignment and agrees to pay the Price noted below, and agrees that such Price will be specified in the Service Agreement and paid to **Transmission Provider**, in accordance with the requirements of the Service Agreement. **Reseller** acknowledges and understands that **Transmission Provider** will credit or charge **Reseller**, as appropriate, for any difference between the Price noted below and the price reflected in the **Reseller** service agreement with **Transmission Provider** with respect to the transmission service assigned hereunder.

This Agreement is intended to be in compliance with and subject to all the terms and conditions of **Transmission Provider’s** Open Access Transmission Tariff (“Tariff”) on file with the Federal Energy Regulatory Commission.

- (iii) **Assignee** represents and warrants that it will comply with all provisions of the Service Agreement and the Transmission Providers Tariff with respect to the rights assigned hereunder.

Terms used but not defined herein shall have the meanings ascribed to them in the Tariff. In the case of a conflict or inconsistency between the terms of this Agreement and the terms of the Tariff, the terms of the Tariff will govern.
