# **Job Description**

The primary functions of the role include project support, tracking and communicating regulatory issue developments, supporting client compliance position tracking, and issue/information tracking and distillation. The Compliance Analyst will assist the team with new market entry, ongoing federal, ISO/RTO, state, and utility compliance, and providing informational support consistent with the needs of CES' clients. - Monitor developments at PUCs, states, and utilities to identify and communicate relevant RPS, retail, or compliance issues to the team and/or to clients where appropriate.
- Prepare and submit ongoing federal, ISO, state, and utility energy load reports.
- Perform other duties as assigned/needed.
