### **Job Description**

The Manager, Wholesale Market Services for the New York Region will be responsible for Customized Energy Solutions' (CES) wholesale services clients and business in the New York Independent System Operator (NYISO) region, which covers the state of New York and power transfers to neighboring regions. The role includes responsibilities for the revenues for the business line in the NYISO region, and management of all wholesale clients in the region. Revenues will be from a combination of scheduling, dispatching, and monitoring services for generation and storage facilities, and from various consulting projects to clients within the region. The position will also involve performing analytical consulting project work geared towards evaluations of the electricity markets.

This opportunity is a hybrid remote position based out of our center city, Philadelphia, Pennsylvania location with close proximity to public transportation and cultural attractions.

## Responsibilities include:

- Coordination of scheduling activities & reporting for wholesale generation and energy storage clients
- Assisting clients with/and performing the registration and testing of resources and Market Participants into the NYISO market
- Participate in market analysis projects focused on the NYISO region, but possibly involving other areas of the deregulated energy markets.
- Develop proposals for projects and communicate with clients or potential clients to revise, refine, and / or adapt proposals to client needs.
- Development of settlement reports, monitoring tools, and other methods of assisting wholesale generation or load clients in maximizing efficiency in the electric markets.
