Company Overview

ONE Gas provides natural gas distribution services to more than 2.2 million customers in Kansas, Oklahoma, and Texas. Headquartered in Tulsa, Okla., its divisions include Kansas Gas Service, the largest natural gas distributor in Kansas; Oklahoma Natural Gas, the largest in the state; and Texas Gas Service, the third largest in the state in terms of customers.

Its largest natural gas distribution markets by customer count are Oklahoma City and Tulsa, Okla.; Kansas City, Wichita and Topeka, Kan.; and Austin and El Paso, Texas. ONE Gas serves residential, commercial, industrial, transportation and wholesale customers in all three states.

RFP Overview

ONE Gas is seeking to purchase RNG attributes in the form of Renewable Thermal Certificates (“RTCs”) via a structured Request for Proposals (“RFP”) administered by Enel X.

ONE Gas will accept offers for RTCs for vintages 2021, 2022, and/or 2023, from projects closest to ONE Gas’ service territory located in Oklahoma (preferred), Kansas, and Texas, as detailed below, via a sealed bid pricing event starting at **9:00 AM CT on Wednesday, June 14, 2023 and ending at 1:00 PM CT Wednesday, June 14, 2023.**

ONE Gas invites your company (“Bidder”) to participate in its upcoming RFP for RTCs and the associated web-based sealed bid pricing event(s) hosted on the Enel X Auction Platform. Please see below for pertinent product and process information.

RFP Process Information

Sealed Bid Pricing Event Format

ONE Gas intends to conduct sealed bid electronic pricing event(s) on the Enel X Auction Platform for the product(s) detailed in the 'Sealed Bid Events List' contained within this RFP document. The sealed bid pricing event(s) will be of a hard-stop format.

During the bidding window, Bidders will be able to enter sealed offers prior to the closure of the sealed bid window. No offers will be accepted after the sealed bid window has closed.

Preliminary Award Notifications

ONE Gas intends to make award notifications immediately after the pricing event(s) conclude. Bidders are required to keep their offer(s) open until award notifications are communicated and through to the execution of resultant contracts. ONE Gas

reserves the right to accept any offers or to reject any and all offers and to re-solicit for additional offers, at its sole discretion.

Final Award Notifications, Contract Execution

Once award notification(s) are made, ONE Gas will communicate with awarded Bidder(s) to execute contract templates containing all relevant and pertinent terms and conditions.

Enel X Platform Demonstration

Demonstrations of the Enel X Auction Platform will be made available upon request. Bidders interested in participating in a platform demonstration are asked to request that a demonstration be scheduled within their submitted RSVP notice.

Enel X Transaction Fee

Enel X will issue awarded Bidders a fee invoice following successful contract execution between the Bidder and ONE Gas. Awarded Bidders will then be responsible for remitting to Enel X a transaction fee, in USD, equal to **\$0.10/MMBtu** (Fee times volume) for each RTC purchased.

Please note that prices entered within the Enel X sealed bid pricing events represent the prices at which ONE Gas would contract. The Seller is responsible for the Enel X fee, and it will be added as a seller's premium to the bid amount. Fees will be invoiced and due from the successful bidder net-30 following execution of contracts between awarded Bidders and ONE.

Enel X Auction Platform Accounts

All recipients of this RFP who intend to participate in the sealed bid pricing events for ONE Gas as a Bidder are required to have user accounts on the Enel X Auction Platform. There are no fees associated with gaining access to the Enel X Auction Platform.

Enel X will establish and issue user accounts to those having submitted affirmative statements of participation intent by **Monday, June 12, 2023**.
