The incumbent must be able to demonstrate excellent written and verbal communication skills, have a strong background in property title searches, and must be proficient with personal computers, Microsoft Word, Outlook, and GIS applications. A valid driver's license is required. This position is required to travel 50% or more by car with occasional overnight stays. This is a Department of Transportation (DOT) (FMCSA) (non-CDL) qualified position.

Senior Property & Right-of-Way Specialist - To perform effectively in this position, the incumbent must have knowledge of real estate operations at a level acquired through the completion of a two-year degree in agriculture, business administration, or related field and five years of experience in right-of-way, real estate, farming, or land management; or a high school diploma or equivalent (GED or HSED) and seven years of related right-of-way experience. A Senior Right-of-Way Agent (SR/WA) designation is required. The incumbent must be able to demonstrate excellent written and verbal communication skills, and must be proficient with personal computers and Microsoft Word and Outlook. A valid driver's license is required. This is a Department of Transportation (DOT) (FMCSA) (Non-CDL) qualified position.

Typical Physical/Mental/Environmental Demands:
